Insurance records, current accident reports, claims, policies, and so on (active and expired)	Permanently
Internal audit reports	1 year
Stock records for products, materials, and supplies	1 year
Invoices (to customers, from vendors)	1 year
Agendas, Minute books, bylaws	Permanently
Payroll records and summaries	1 year
HR files (terminated employees)	1 year
Retirement and pension records	Permanently
FATC Tax returns and records	Permanently
Timesheets	1 year
Finance and other data in respect to EPCDF lending	10 years
